## 1.0 INSTRUCTIONS FOR REVIEW

---

This document includes the proposed questionnaire for the Utah Statewide Household Travel Survey (HTS). This questionnaire covers participation in the web, app, and call center instruments. All content will be available in both English and Spanish in the final programmed surveys. Note that some text in this questionnaire (Sections 2.0, 4.0, 12.0, 13.0, and 16.0) are part of the app and used across many projects. This text cannot be changed.

### Questionnaire Sections:

The survey is divided into several sections:

- A **signup survey** that one member of the household completes at the beginning of the study.

- **Daily surveys** that each adult member completes after each travel day. These surveys are split across the seven-day travel period for app participants. Web and call center participants will see all questions at the same time after their single travel day. Note that some questions are asked every day and some questions are asked only once during the travel period.
- **Proxy surveys** that one adult completes on behalf of each child in the household. These are similar to daily surveys but are tailored to child travel (e.g., asking about travel to school).
- **Trip surveys** that each member completes after each reported or app-detected trip.

#### Notes for Review:

- Variable / page names are noted in brackets and capital letters. These are **not** indicative of the variable names that will be delivered in the final dataset. These names are used for programming (and are included here to allow QC of the final programmed instrument).
- Programmer notes are included in red italics. Survey logic is included in blue italics.
- Single-select (radio) questions are noted with open circle bullets. Multi-select (checkbox) questions are noted with open square bullets.

- 3.1 – the intro listing all sponsor names – this is a pretty long list, especially if reading on a phone screen. Any thought to customizing this to the agency most relevant to the home geography?

- 3.2 – incentive. I’m assuming you don’t list an amount or value of gift card here as differential incentives will be used?
  -
- 3.9 – toll transponder. Based on a google search, there may only be one toll road in the state – is this a relevant question?
  -
- 3.10 – vehicle ownership – I agree with Natalie’s question – possibly delete?
  -
- 3.11 – household size – I agree here as well to move to including you, how many people.
  -
- 3.15 – age – why not just ask the age instead of listing categories?
  -
- 3.20 – school type – why the age ranges of 0-15, 5-15, and 5-24 for elem, mid, and high school? (as in these very wide ranges for each school type vs. something closer to reality)?
  -
- 3.22 second home – given the desire to understand travel of seasonal residents, we should consider separate questions for seasonal residents (here in Utah, but recognize some Utah residents will have a 2<sup>nd</sup> home elsewhere) vs. locals with more than one “home” from an administrative point of view. I recommend we consider revising this question and have a couple questions re: seasonal homes (where is primary home, how long stay in Utah)

- 6.11 – does the respondent see this full list again or is it trimmed to match what they report as benefits in 6.10?
  - The list will be trimmed to match what they report as benefits
- 9.5 and 9.6 – this residence or your current residence?
  - The questions are intended to ask about their current residence
